

### **1- WHY SHOULD YOU REGISTER?**



The Social Security (Assurance Maladie) is the French health system. It is a welfare regime which gives you access to fully refunded medical bills and other health expenses (presriptions, specific treatments, dentist, ophtalmologist, hospitalisation, medical service...)

Registering to Social Security is FREE. All steps are accessible via the online platform. You can reach a phone platform, as well. The Assurance Maladie can also welcome you at their office in Nice: 7 rue Pertinax, 06000 Nice, Monday through Friday from 8 AM to 4 PM.

In Cannes: 2 rue de la Verrerie, 06150 Cannes, on Tuesdays from 1:30PM to 3:30PM and on Thursdays from 8:30AM to 12:30PM.

#### **OBLIGATOIRE**

Registering to Social Security is MANDATORY. As soon as your administrative registration is completed at the University, you can get started on the steps to sign up to an account on the Ameli platform.



## **2-HOW CAN YOU REGISTER?**



### **TEMPORARY CERTIFICATE**

n order to register to Social Security, you have to get a few papers ready which will be required to create your account. They will grant you your temporary certificate:

- a proof of enrolment from the University;
- a form of ID (card, passport...);
- a student visa.



#### **PERMANENT CERTIFICATE**

Once you have received your tempo certificate, you will need to provide of credentials to update your file and get permanent certificate, which will state your rig

- a proof of civil status;
- your resident permit;
- your International Bank Account Nur (IBAN).

# **3- MANAGING YOUR SOCIAL SECURITY RIGHTS**



### **YOUR CARTE VITALE**

Your certificate of social security number, also called a matriculation allows to you fill a form to request your Carte Vitale. This card comes with a microchip, your personal information (name, social security number) and your ID photograph.

All you need is to show it at the pharmacy when you go get your prescription filled or to your GP and your expenses will be covered.



#### **AMELI ACCOUNT**

AMELI (Assurance Maladie En LIgne) is the Social Security online platform. Whether via the website or the app (App Store or <u>Google Play</u>), you can access your personal account to check your refunds and you have several tools at your disposal to guide you through the process.





Your health expenses are fully covered as long as they remain primary (medical exams, drug prescriptions...). For more specific treatments, there are supplementary health insurances, or health mutuals, which chargeable. However, offers Assurance Maladie the the Complémentaire Santé Solidaire: it is free and it covers most of the health expenses.

## FOR MORE INFO



If you are from an EU country, an EEA country or from Switzerland, you have the right to request an EHIC (European Health Insurance Card).
